Class Cancellations

Classes may be canceled without penalty up to **12 hours before the scheduled class start time**.

Late Cancellations

Cancellations made less than 12 hours before class start time are considered late cancellations.

The following penalties may apply:

Membership Holders

A late cancellation fee may be charged.

Class Package Holders

One class credit may be forfeited.

No-Shows

Failure to attend a reserved class without cancellation is considered a no-show.

The following penalties may apply:

- Loss of class credit
- Additional no-show fee
- Temporary booking restrictions
